#### Terms of Service

**Effective Date:** September 1st, 2025

**Last Updated:** August 30th, 2025

These Terms of Service ("Terms") govern your use of **Crab** ("the Application"), a Discord application developed and maintained by **Tropical Systems** ("we," "us," or "our"). By inviting, using, or interacting with the Application in any Discord server, you agree to be bound by these Terms. If you do not agree, you may not use the Application.

## 01. Eligibility

- You must comply with [Discord's Terms of Service](#) and [Community Guidelines](#).
- You must be at least **13 years old**, or the minimum age of digital consent in your country, whichever is higher.
- By using the Application, you represent and warrant that you meet these requirements.

## 02. Use of the Application

- You are granted a limited, revocable, non-exclusive right to invite and use the Application in Discord servers that you own or administer.
- You agree not to use the Application for:
  - Harassment, bullying, discrimination, or hateful conduct.
  - Spamming, flooding, or otherwise disrupting server functionality.
  - Automating prohibited actions on Discord.
  - Any illegal activity or activity violating Discord's rules.
- The Application may include moderation tools. **Server owners and administrators are solely responsible** for how the Application is configured and used in their server.

### 03. User Responsibilities

- You are responsible for ensuring that your server complies with these Terms and Discord's policies.
- You agree not to exploit bugs, errors, or vulnerabilities in the Application.
- You are responsible for securing any permissions you grant the Application (such as Administrator rights) and acknowledging that misuse may cause unintended consequences.

### 04. Data Collection & Privacy

- The Application may collect and store limited data to provide functionality, including:
  - **Identifiers:** User IDs, Guild IDs, Channel IDs.
  - **Configuration Data:** Server settings, preferences, and logs related to the Application's features.
  - **Interaction Data:** Commands and interactions with the Application.
- We do **not** collect message content unless explicitly necessary for a feature (e.g., logging or moderation systems).
- Data is used only for the functionality of the Application and is not sold or shared with third parties.
- Data may be deleted upon request from the server owner (or automatically when the Application is removed).

### 05. Availability & Updates

- The Application is provided "**as is**", with no guarantee of uptime, reliability, or uninterrupted service.
- Features may be added, modified, or removed at any time.
- We may temporarily or permanently suspend the Application without prior notice (for maintenance, abuse prevention, or other reasons).

## 06. Intellectual Property

- All source code, features, branding, and related assets of the Application are the property of **Tropical Systems**, unless otherwise stated.
- You may not copy, modify, distribute, or host instances of the Application without our written permission.
- Any unauthorized attempts to reverse-engineer or duplicate the Application may result in termination of access and potential legal action.

## 07. Limitation of Liability

- We are not liable for:
  - Loss of data, server issues, or disruptions caused by the Application.
  - Actions taken by server administrators using the Application's features.
  - Any damages, direct or indirect, resulting from use of the Application.
- Your use of the Application is entirely **at your own risk**.

## 08. Termination

- You may remove the Application from your server at any time.
- We reserve the right to terminate or restrict the Application's availability to any user or server at our discretion, including (but not limited to) violations of these Terms or Discord's policies.
- Upon termination, any stored data associated with your server may be deleted.

## 09. Changes to the Terms

- We may update these Terms at any time.

- Updates will take effect once published, and your continued use of the Application constitutes acceptance of the new Terms.
- Significant changes may be announced through [our support server](#).

## 10. Governing Law

- These Terms shall be governed by and construed under the laws of the United States of America and the State of Kansas.
- Any disputes shall be resolved in accordance with the applicable jurisdiction in Kansas.
